1 Croeso ac Ymddiheuriadau / Welcome and Apologies

Bu Gareth Winston Roberts gadeirio'r cyfarfod a chroesawu pawb yn bresennol.
Gareth Winston Roberts chaired the meeting and welcomed all present.

2 Datgan Diddordeb / Declaration of Interest

3 Cofnodion y Cyfarfod Diwethaf / Minutes of the Last Meeting

Cymeradwywyd cofnodion y cyfarfod diwethaf; cynnig Myrddin Owens, eilio Gordon Warren
Minutes of the last meeting were approved; proposed Myrddin Owens, seconded Gordon Warren.

4 Materion yn Codi / Matters Arising

Cafwyd gadarnhad bod gwaith i wella hygyrchedd palmentydd y dref bellach wedi dechrau.
It was noted that the work to improve accessibility and dropped kerbs had by now commenced.

5 Pwyllgorau Allanol / External Meetings

- 5.1 Cafwyd adroddiad gan Gordon Warren yn dilyn cyfarfod Fforwm Cyswllt Mon. Bu iddo bwysleisio pwysigrwydd hyfforddiant yn enwedig y Cod Ymddygiad. Bu iddo hefyd gadarnhau bod gwaith yn parhau ar ddatblygiad ger Maes Mona, mae disgwyl i'r broses gynllunio gael ei gwblhau yn ystod 2023/24 a'r gwaith adeiladu i ddechrau yn 2024/25.

Bu gofyn i'r clerc wneud ymholiadau os fydda posib cynnal sesiynnau hyfforddiant penodol ar gyfer y Cyngor Tref, o bosib ar y cyd gyda cynghorau lleol eraill.

A report was given by Gordon Warren following the meeting of the Anglesey Liaison Forum. He emphasised the importance of training especially the Code of Conduct. He also confirmed that work continues on development near Maes Mona, the planning process is expected to be completed during 2023/24 and the construction work to start in 2024/25.

The clerk was asked to make inquiries if it is possible to hold specific training sessions for the Town Council, possibly in conjunction with other local councils.

- 5.2 Cafwyd wybod bod yr Eglwys wedi cyflwyno cais grant i'r Gymdeithas yn dilyn cyfarfod gyda rhai aelodau'r Cyngor. Pwysleiswyd bod yr Eglwys yn adeilad bwysig iawn i dref Amlwch, a bod cais wedi ei gyflwyno am waith i'r twr mewn ddau rhan.

It was noted that the Church had submitted a grant application to Y Gymdeithas following a meeting with some members of the Council. It was emphasised that the Church is a very important building for the town of Amlwch, and that an application had been submitted for work to the tower in two phases.

- 5.3 Bu Meg Roberts ddatgan ei bod wedi sefyll i lawr yn gadeirydd 1wyllgor Clwb y Gorlan a bu cytuno penodi aelod newydd i'r pwyllgor yn y cyfarfod nesaf. Y clerc i gynnwys eitem ar yr agenda.

Meg Roberts noted that she had stood down as Chair of Clwb y Gorlan, and it was agreed to appoint a new member to the committee at the next meeting; the clerk to include an item on the agenda.

6 Adroddiad Pwyllgor Cyllid / Finance Committee Report

Cafwyd grynodedb gan Myrddin Owens o'r hyd drafodwyd yng nghyfarfod diwethaf y Pwyllgor. Nodwyd bod nifer o daliadau wedi eu cymerawdwo yn ol yr arfer. Trafodwyd cais am gefnogaeth ariannol gan Hosbis Dewi Sant (Caergybi) a bu'r Pwyllgor argymell cyfrannu £500, bu'r Cyngor Llawn yn gefnogol. Cafwyd wybod bod cais hefyd wedi ei dderbyn gan Gwmni Theatr Eleth a bod y clerwr am gysylltu am fwy o wybodaeth cyn i'r Pwyllgor ystyried y cais.

Bu adroddiad yn dilyn cyfarfod gyda tenantiaid Caban y Cei, bu cymeradwyo telerau newydd a nodi sut byddai gwahanu costau trydan wrth symud ymlaen. Bu hefyd cymeradwyo gwerthu sglodion.

Bu dosbarthu cofnodion y cyfarfod a gynhaliwyd gyda Comisiynydd yr Heddlu. Bu'r aelodau nodi eu siom nad oedd ganddo unrhyw atebion yn y cyfarfod ac dal i ddisgwyl mwy o wybodaeth gan ei swyddfa.

Bu rhannu diweddariad gyda'r aelodau ynglyn a'r prosiect effeithlonrwydd ynni a chytuno yn unfrydol byddai'r clerwr a Myrddin Owens yn trefnu cwrdd a chyfreithiwr i drafod ymhellach.

Trafodwyd y Gronfa Ffyniant Cyffredin, gan nodi bod CSYM wedi cysylltu yn fyr rybydd iawn gyda gwybodaeth ac i gydlynnu cais am yr arian sydd wedi ei glustnodi i'r ynys. Nodwyd siom am amseru'r cyswllt a diffyg rhybydd. Cytuno byddai cysylltu a'r cynghorau tref eraill a threfnu bod cyfarfod Trefi Mon yn cael ei drefnu cyn gynted a phosib. Cytuno hefyd trefnu cyfarfod aelodau Cyngor Tref Amlwch, aelodau sirol a swyddogion perthnasol i drafod syniadau posib ar gyfer prosiectau i'r dyfodol. Bu'r Cyngor Llawn yn unfrydol gefnogol.

Nodwyd bod unigolyn wedi bod yn torri a dwyn y cennin pedr gyferbyn a Clwb y Gorlan. Mae'r achos wedi ei ddwyn at sylw'r heddlu gyda lluniau yn dystiolaeth. Bu argymell bod y Cyngor yn hawlio Cadeirydd y Pwyllgor i gynrychioli'r Cyngor yn y mater. Ni fu gwrthwynebiad.

Myrddin Owens gave a summary of what was discussed at the Committee's last meeting. It was noted that a number of payments had been approved as usual. A request for financial support from St David's Hospice (Holyhead) was discussed and the Committee recommended contributing £500, the Full Council was supportive. It was reported that an application had also been received from the Eleth Theatre Company and that the clerk was to ask for more information before the Committee considered the application.

A summary was given of a meeting with the tenants of Caban y Cei, new terms were approved and it was noted how electricity costs would be apportioned moving forward. The sale of chips was also approved.

The minutes of the meeting held with the Police Commissioner were distributed. The members noted their disappointment that no answers were given at the meeting and information is still expected from his office.

An update was shared with the members regarding the energy efficiency project and it was unanimously agreed that the clerk and Myrddin Owens would arrange a meeting with a lawyer to discuss further.

The Shared Prosperity Fund was discussed, noting that IACC had contacted the clerk at very short notice with information and to coordinate a request for the money that has been earmarked for the island. Disappointment was noted at the timing of the contact and lack of notice. It was agreed that contact would be made with the other town councils and arrange that a Trefi Mon meeting be arranged as soon as possible. Also agreed to organise a meeting of Amlwch Town Council members, county councillors and relevant officers to discuss possible ideas for future projects. The Full Council was unanimously supportive.

It was noted that an individual had been cutting and stealing the daffodils opposite Clwb y Gorlan. The matter has been brought to the attention of the police with photos as evidence. It was recommended that the Council authorise the Chairman of the Committee to represent the Council in the matter. There was no objection.

7 Adroddiad Pwyllgor Parciau a Mannau Agored / Parks and Open Spaces Committee Report

Cafwyd wybod gan Gordon Warren bod y rhai aelodau'r Pwyllgor wedi cwrdd er mwyn ymweld ag ardaloedd penodol a chreu rhestr gwaith. Nodwyd bod y Gardd Goffa / 'Oval' angen sylw, mae cymlethdod ynglyn a phwy sy'n gyfrifol am y llecyn (CSYM neu'r Eglwys). Y Clerc i anfon y wybodaeth berthnasol ymlaen i Aled Morris Jones iddo ymchwilio' mhellach.

Daw rhodd o goeden gan grwp ysgrifennu creadigol a bydd i'w blannu ym Mharc Lon Goch yn fuan. Bu tynnu sylw at ddifrod ar ran o arwyneb diogelwch yn un rhan o'r parc a chadarnhau bod gwaith i'w drin wedi ei gadarnhau. Mae Meg Roberts yn trefnu bod blodau yn cael eu harchebu a'u plannu ble bo angen.

Trafodwyd pryderon am sbwriel tu cefn i erddi tai Craig y Don. Nodwyd bod llythyr wedi ei ddanfon at drigolion pob ty yn tynnu sylw. Y clerc i anfon at Liz Wood ac Aled Morris Jones i gael diweddariad am y pryderon ffiniau oedd wedi eu trafod eisioes gyda swyddogion adran tai CSYM. Bu tynnu sylw am pentwr o sbwriel wedi ei adael ar dir Network Rail ger safle Octel, mae CSYM mewn cyswllt a'r cwmni.

Gordon Warren noted that some Committee members had met in order to visit specific areas and create a work list. It was noted that the Memorial Garden / 'Oval' needs attention, there is complication as to who is responsible for the spot (IACC or the Church). The Clerk to forward the relevant information to Aled Morris Jones to investigate further.

A gift of a tree comes from a creative writing group and it will soon be planted in Lon Goch park. Attention was drawn to damage to part of a safety surface in one part of the park and it was confirmed that work to repair it had been confirmed. Meg Roberts will arrange that flowers are ordered and planted where necessary.

Concerns about litter behind the gardens of Craig y Don houses were discussed. It was noted that a letter had been sent to the residents of each house drawing attention to the issue. The clerk to send to Liz Wood and Aled Morris Jones to get an update on the boundary concerns that had already been discussed with IACC housing department officers. Attention has been drawn to a pile of rubbish left on Network Rail land near the Octel site, IACC is in contact with the company.

9 Cwestiynau i'r Cynghorwyr Sirol / Questions to the County Councillors

Bu Aled Morris Jones dynnu sylw am bryderon bod CSYM yn bwriadu cwtogi'r gwasanaethau bws yn yr ardal. Cynnigwyd bod Aled Morris Jones yn trefnu cyfarfod gyda'r swyddogion perthnasol, cynnig Myrddin Owens, eilio Meg Roberts.

Bu tynnu sylw at gynnigion CSYM i godi'r dreth cyngor 5% ar gyfer 2023/24.

Bu Gerry Belanger ofyn pam nad oedd datblygiad pellach gyda'r unedau diwydiannol i Amlwch. Nodwyd bod arian wedi ei ddiogelu i dalu am adnabod y tir a datblygu cynlluniau a bod hyn eisioes ar y gweill.

Nodwyd bod angen i'r warden gwn ymweld a'r dref, gyda chwynion mewn ardaloedd penodol wedi'i nodi.

Bu tynnu sylw at y diffyg llinellau melyn tu allan i fwyty Rozi's a'r pryderon sy'n parhau am y gyffordd yma. Aled Morris Jones i gysylltu a CSYM i ofyn am adolygiad eto.

Aled Morris Jones drew attention to concerns that the IACC intends to curtail bus services in the area. It was proposed that Aled Morris Jones organise a meeting with the relevant officers, proposed by Myrddin Owens, seconded by Meg Roberts.

Attention was drawn to IACC proposals to raise the council tax by 5% for 2023/24.

Gerry Belanger asked why there was no further development with the industrial units for Amlwch. It was noted that money has been secured to pay for identifying the land and developing plans and that this is already underway.

It was noted that the dog warden needed to visit the town, with complaints in specific areas noted.

Attention was drawn to the lack of yellow lines outside Rozi's restaurant and the ongoing concerns about this junction. Aled Morris Jones to contact the IACC to ask for a review of the situation.
