1 Croeso ac Ymddiheuriadau / Welcome and Apologies

7 Cyllideb ac Archeb 2024/25 Budget and Precept

Roedd copi o'r gyllideb arfaethedig a'r archeb wedi'u hafnon at yr holl aelodau cyn y cyfarfod.

Rhoddodd Myrddin Owens drosolwg I bawb. Cytunwyd I godi yr Archeb o 5% sy'n golygu y bydd Band D yn cynyddu o £71.07 I £74.62. Cynigiwyd gan Gerry Belanger, eilwyd gan Meg Roberts, pasiwyd yn unfrydol. Nodwyd mai ni yw'r dref isfa ar yr Ynys o hyd, heblaw am Fiwmares.

A copy of the proposed Budget and Precept had been sent to all members prior to the meeting.

Myrddin Owens gave an overview to all. It was agreed to increase the precept by 5% which means Band D will increase from £71.07 to £74.62. Proposed by Gerry Belanger, Seconded by Meg Roberts, Unanimously passed. It was noted that apart from Beaumaris we are still the lowest Town on the Island.

9 Diweddariad Adeiladau Porth Amlwch / Amlwch Port Buildings Update

Cafwyd diweddariad ar y prosiect gan Gareth Roberts a Myrddin Owens. Mae Gwaith yn cael ei wneud yn y cefndir a diolchwyd I'r ddau. Cytunwyd y byddai Cyngor Tref Amlwch yn rhyddhau hyd at £50,000 o'r pot Canatax tuag at y prosiect.

Update on project was given by Gareth Roberts and Myrddin Owens. Work is being undertaken in the background and both were thanked. It was agreed that Amlwch Town Council would release up to £50,000 from the Canatax pot towards the project.
